I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES FOR ANY INJURY RESULTING TO MYSELF OR OTHERS, OR MY PROPERTY OR THE PROPRIETY OF OTHERS, ARISING FROM, OR IN CONNECTION WITH SAID ACTIVITIES. In consideration of my being allowed to participate in the ACTIVITIES, I agree to indemnify and hold harmless the Released Parties from any and all liability, claims, causes of action, demands, damages, or any other forms of relief which might be made against any or all of the Released Parties whatsoever, howsoever arising, directly or indirectly out of or in consequence of my attendance at or participation in the ACTIVITIES.
